I'm writing to request your service on the newly established University Budget Advisory Committee.

NC State is facing complex and fast-changing budget pressures due primarily to the COVID-19 pandemic, and consequences of the financial impact at the federal, state, UNC-System and university level. Convening a University Budget Advisory Committee is designed to ensure university leadership is informed of concerns from across the university, and to ensure the university community is informed of administrative and operational decisions as quickly and transparently as possible.

The University Budget Advisory Committee is charged with:

- Advising Vice Chancellor Maimone on COVID-19-impacted budget concerns,
- Ensuring budget and financial decisions are consistent with and support the long-term mission of NC State University, and align with the university's stated strategic goals,
- Communicating budget-related information to constituents in a timely, consistent and informed manner.

We anticipate the University Budget Advisory Committee will meet monthly through the remainder of the fiscal year.
